## 1 Minutes of Previous Meeting

Minutes of 15<sup>th</sup> September meeting approved.

Agreed to reconsider venue of the open committee meeting for next year.

# 3 <u>Finance Update</u>

Accounts to date presented. It was estimated that the club would show a £650 profit for the year but noted that the non-guaranteed income for the year was £4,707.50.

Agreed to keep a log of vests to show where money is spent and how much is received back. Similarly, LiRF vouchers where we have the asset but not cash.

England Athletics fees for 2020/21 to be increased by £1. Currently:

Income:	New members	£40
	Early bird renewal	£25
	Regular renewal	£30

Therefore, the club received a surplus of £6 for new members, £10 for early bird renewals and £15 for regular renewals.

Agreed that we could not absorb the EA increase and so fees for next year would increase to £41 for new members, £26 for early bird renewal and £31 for regular renewals.

Also agreed to increase second claim fees, currently a one-off fee of £5 plus the cost of the vest, to £5 per year, for new joiners only.

#### Road
